- 4. Consider approval of audit relative to the payment of proceeds of the District's \$15,240,000 Unlimited Tax Bonds, Series 2016A (the "Bonds"), and consider authorizing disbursement of Bond proceeds in accordance with same;
- 5. Consider and act upon authorizing execution of an Amendment to the District's Information Form relative to the Bonds;
- 6. Consider approval and execution of Conveyances of Utility Facilities relative to facilities to be purchased with Bond proceeds;
- 7. Consider acceptance and execution of Receipt and Releases relative to funds disbursed in connection with Bond proceeds;
- 8. Consider approval of amendment to existing Agreement for Independent Contractor Services (Security Patrol Services);
